In accordance with the Transportation Security Administration (TSA) Regulation 49 CFR 1542.209, a Criminal Records History Check (CHRC) conducted by the Federal Bureau of Investigation (FBI) will be used to determine an applicant's suitability for access to authorized areas of Manchester-Boston Regional Airport (MHT). 9.) Aircraft piracy outside the special jurisdiction of the United States; 49 U.S.C. 46502(b)	23.) Distribution of, or intent to distribute, a controlled substance
10.) Lighting violations involving transporting controlled substances; 49 U.S.C. 46315	24.) Felony arson
11.) Unlawful entry into an aircraft or airport area that serves air carriers or foreign air carriers contrary to established security requirements; 49 U.S.C. 46314	25.) Felony involving a threat
12.) Destruction of an aircraft or aircraft facility; 18 U.S.C. 32	26.) Felony involving -- (i) Willful destruction of property; (ii) Importation or manufacture of a controlled substance; (iii) Burglary; (iv) Theft; (v) Dishonesty, fraud or misrepresentation; (vi) Possession or distribution of stolen property; (vii) Aggravated assault; (viii) Bribery; (ix) Illegal possession of a controlled substance punishable by a maximum term of imprisonment of more than 1 year

14.) Assault with intent to murder	28.) Conspiracy or attempt to commit any of the criminal acts listed

I have reviewed the above information and certify that I have not been convicted of any disqualifying criminal offenses.

I have been advised that Federal Regulations under 49 CFR 1542.209 impose a continuing obligation to disclose to the airport and the aircraft operator within 24 hours if I am convicted of any disqualifying criminal offense that occurs while I have unescorted access authority. I also understand that a finding of any disqualifying criminal offense prohibits issuance, or requires surrender of access media.

The information I have provided on this application is true, complete, and correct to the best of my knowledge and belief and is provided in good faith. I understand that a knowing and willful false statement on this application can be punished by fine or imprisonments or both. (See Section 1001 of TITLE 18 United States Code)
